## **Sub:** Review of Implementation of Right to Service Act.

- 3. I intend to hold a detailed meeting at 3.00 PM on 31/10/2011 with the district officers of the following department –
- (1) **Revenue** (1 Tehsildar) may kindly be invited;
- (2) **Food Supplies** (1 AFSO) may be asked to attend the meeting;
- (3) **Health** (Civil Surgeon alongwith one SMO) may be asked to attend the meeting.
- (4) **Municipal Committees** (Commissioner of Municipal Corporation, 1 Engineer of MC, 1 Assistant Municipal Engineer of MC, EO of Improvement Trust, one incharge for

birth and death registration in MC) may be asked to attend the meeting;

- (5) **Transport** (DTO/SDM, MVI, SO in DTO Office and Secretary, Regional Transport Authority) may be asked to attend the meeting.
- (6) **Water Supply & Sanitation** (1 SDO) may be asked to attend the meeting;
- (7) **Social Security, Women and Child Development** ((1 District Social Security Officer) may be asked to attend the meeting;
- (8) **Housing Development & Urban Development** (EO & SDO Buildings) may be asked to attend the meeting.
- 4. The following items are proposed to be discussed in this meeting –
- (1) Installation of computer and recruitment of computer operators;
- (2) Display Board in the office of Designated Officers, Fard Kendras and Suvidha Centres;
- (3) Details of Suvidha Centres in your district and the number of services all 47 being provided therein;
- (4) Application form along with check-list for each of 47 services;
- (5) Compilation of details of applications received by Designated Officers in format RTS-I;
- (6) Monitoring of work of Designated Officers by SDM and Deputy Commissioner.
- (7) Delivery Points We have to take a final decision about Sub Divisional Suvidha Centre for the services being provided at the district level and vice-versa.
